COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I**Charge: Interfere with privacy - Against minor Under 18; Violate (b), (d) or (e); More than 36 months older**

Minnesota Statute: 609.746.1(h), with reference to: 609.746.1(h)

Maximum Sentence: 4 years and/or \$5000

Offense Level: Felony

Offense Date (on or about): 04/17/2024

Control #(ICR#): 24019737

Charge Description: That on or about 4/17/2024, in Brooklyn Park, Hennepin County, Minnesota, JASON GARY POLZIN, used a device for photographing, recording, or broadcasting an image of an individual in a changing room or any place where a reasonable person would have an expectation of privacy, with intent to photograph, record, or broadcast an image of the individual's intimate parts, without the consent of the individual, and violation was against a minor victim under the age of 18; (2) JASON GARY POLZIN is more than 36 months older than the minor victim; (3) JASON GARY POLZIN knew or had reason to know that the minor victim was present; and (4) the violation was committed with sexual intent.

Complainant, a licensed peace officer with the Brooklyn Park Police Department, has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On May 23, 2024, Brooklyn Park Police Officers were dispatched to Living Word Christian Center, located in Brooklyn Park, Hennepin County, Minnesota, on a sexual misconduct call. Upon arrival, officers learned that a staff member, JASON GARY POLZIN (date of birth 05/15/1975), the defendant herein, recorded a 13-year-old girl, hereinafter referred to as Victim, as she changed clothes.

Officers learned that a report was made by the Victim's friends. Officers also learned that the incident occurred a few weeks prior, on April 17, 2024.

Victim was interviewed at CornerHouse. She reported that the defendant was a staff member who helped with the softball team. Victim stated that the defendant allowed her to use his classroom to change clothes prior to softball. Victim stated that on the day in question, she was changing in the defendant's classroom when she noticed the defendant's phone was in the room. Victim checked the phone and observed that it was pointed at her and was recording. Victim stated that the video showed the defendant looking at the door before he set the phone down and aimed it so it was pointed towards where she would be changing. Victim stated that she deleted the video.

Victim reported that she confronted the defendant about the video. She stated that the defendant claimed it was an accident. Victim stated that she told a friend and later talked about the incident with school personnel. Victim reported that the defendant would give her rides and invited her to go on his boat. Victim stated that she felt confused and angry when she found his phone recording her.

Officers conducted a search warrant at the defendant's home in Prior Lake and collected a number of electronic devices belonging to the defendant. Law enforcement performed forensic analysis of the devices and located a number of files of Criminal Sexual Abuse Material. Additionally, officers located 52 photos of Victim, the majority of which were taken in the defendant's school office. Officers also located 165 photos that were Victim's face on a computer-generated female body. Included in those 165 photos were photos of Victim's face on a naked female body or a female body wearing revealing lingerie.

The defendant is currently in custody.

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.

Complainant declares under penalty of perjury that everything stated in this document is true and correct. Minn. Stat. § 358.116; Minn. R. Crim. P. 2.01, subds. 1, 2.

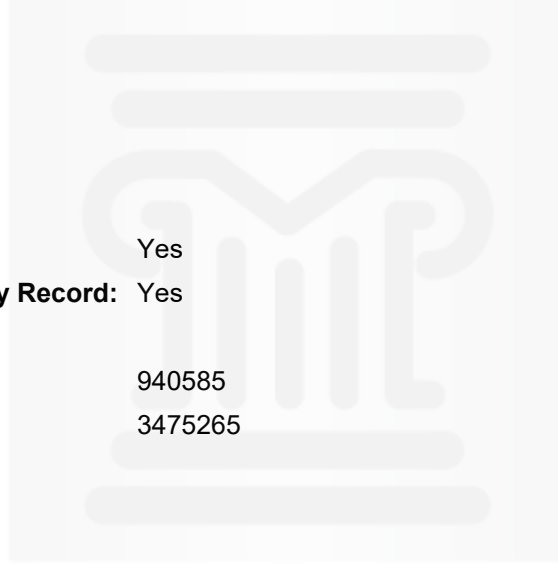
